- There had been an agreement with the University to move the coastal footpath inland at the site of the erosion; also funding applications were being made for the cost of repairing the coastal footpath in two locations
  - Footpaths at Maesgwyn and the one blocked by the chain were being looked at
  - The waste collection service was being affected by a shortage of drivers
  - The replacement Llanon sign at Pennant was awaited
  - Work on ash die-back was scheduled for trees at Nebo and Cylch Peris, Llanon
  - There had been a meeting to review the service provided by Clic
  - The disappearance of the cones on Stryd Fawr was being followed up.

- a) Consideration was given to the information provided by Ms Alison Reed that the Tennis Club was being wound up and requesting that the balance of £270 in its bank account be transferred to the Council. The Clerk explained the background to the matter. It was **RESOLVED** to note the winding up of the Club and to agree to receive the £270.
