I refer to your email dated 9 November 2017 regarding Heol-Llain-Prysg in Llanon. This road has been highlighted by the Highway Inspector as being in need of a resurfacing treatment. Having regard to this referral we have programmed resurfacing treatment from the junction with Stryd yr Ysgol to the entrance of the property known as Tan-y-Fron. It is intended that this treatment will be carried out sometime in the 2018/19 financial year.
