**83 Hysbysfwrdd ar gyfer Llansantffraed**  
Rhoddyd ystyriaeth pellach i bedwar pris a dderbyniwyd am ddarparu hysbysfwrdd i'w osod yng Nghylch y Llan, Llansantffraed. Eglurodd y Clerc fod y pris a roddwyd gan Earth Anchors am hysbysfwrdd powdwriw ac mai hwn oedd yr un isaf. Gofynnodd hefyd am y dewis liw.  
Yn dilyn trafodaeth, **PENDERFYNWYD**:

Members maintained that the process should have been undertaken by way of a tendering exercise.

County Councillor Dafydd Edwards stated that he could provide a list of approved contractors used by the County Council for this type of work.

It was suggested that the work identified in the schedule of anchoring / re-attaching benches to concrete plinths need not be undertaken.

It was therefore **RESOLVED**:

- i) to settle the invoice for £180 in respect of the inspection work undertaken and the schedule prepared by Mr Lloyd;
- ii) to remove the Cylch y Llan bench owing to its dangerous condition; and
- iii) to note receipt of the quote submitted by Mr Lloyd for the renovation work and provide an opportunity for other contractors to quote for the work listed in the schedule of work.

**81.3** The arrangement for erecting and lighting the Christmas Tree on Friday 8<sup>th</sup> December and the refreshments were agreed.

**82 Property Matters – Monthly Inspection**

Councillor Lowri Jones presented her report following her inspection and referred to the condition of the safety matting in certain areas of the playground. The Clerk was requested to ensure that any necessary repairs to the safety matting was included in the work to be undertaken by the County Council.

**83 Noticeboard for Llansantffraed**

Further consideration was given to four quotes received for the provision of a noticeboard to be erected at Cylch y Llan, Llansantffraed. The Clerk clarified that the quote received from Earth Anchors was for a powder-coated noticeboard and that it was the lowest. He also asked which colour was required.
