319 Maes Parcio'r Morfa

a) Cymryd rheolaeth o'r maes parcio

Cafwyd cadarnrhad, mewn ebost ar 8 Ebrill 2019, gan Adran Dir y Cyngor Sir nad oedd ganddynt gofnod mai nhw oedd yn berchen ar y tir dan sylw. Felly, **PENDERFYNWYD**, os byddai'r Cyngor Cymuned am wella'r ardal er budd y gymuned, y byddem yn bwrw ymlaen i wneud hynny ac yn talu'r gost o'r gyllideb .

b) Tynnu'r cerrig o'r maes parcio

Nid oedd neb yn ffafrio'r opsiwn gwreiddiol a gynigwyd, sef derbyn y dyfynbris o £1,500 i wneud y gwaith clirio.

Ar ôl trafod pa waith yr oedd angen ei wneud, **PENDERFYNWYD** derbyn yr ail ddyfynbris - gan Gwyndaf Jenkins - a fyddai'n gwneud y gwaith mewn un diwrnod llawn am rhwng £500 a £600. Byddai Mr Jenkins yn cwblhau'r gwaith ddydd Llun neu Mawrth yr wythnos ganlynol, ac yn clirio'r cerrig yn ôl heibio'r bwi achub ac mewn llinell â'r banc.

Cytunodd y Cyngorydd Aled Roberts i

319 Morfa Car Park

a) Taking control of the car park

Confirmation had been received by way of an e-mail dated 8 April from the County Council Estates Department that they had no record that they owned the land in question. Therefore, it was **RESOLVED**, should the Community Council wish to improve the area for the benefit of the community, to proceed to do that and meet the cost from its budget.

b) Removing the stones from the car park

No one favoured the original option which had been offered, namely to accept the quotation of £1,500 to undertake the clearing work. Following consideration of the work required, it was **RESOLVED** to accept the second quotation – submitted by Gwyndaf Jenkins – who would undertake the work in one full day for between £500 and £600.

Mr Jenkins would undertake the work on either the Monday or Tuesday of the following week and clear the stones beyond the lifebuoy and in line with the bank.

Councillor Aled Roberts agreed to
