455 Council's Budget 2020-21

Consideration was given to the Draft Budget for 2020-21 as prepared by the Clerk.

Members noted the renovation of the benches and the replacement chalet would not proceed until the following financial year and that provision should be made for these two schemes.

Members also discussed the price provided earlier by County Councillor Dafydd Edwards for the provision of street lights between the dwellings Morawel and Pengarreg at Nebo and it was agreed to provide a sum of £4,000 in the budget for this purpose.

It was therefore **RESOLVED** as follows:

- i) to approve a budget of £23,705;
- ii) to set a Precept of 15,000, with a Council Tax of £27.65 on Band D properties;
- iii) with regard to the grant already approved by the County Council in the sum of £2,992 towards the cost of a new chalet, to request the County Council to carry it forward to the next financial year; and to utilise £5,713 of reserves.

- 457 Request of Llanon Football Club Trustees in respect of the Changing Rooms**
- Bryan Tomlins, in his capacity as one of the Trustees of the Football Club, stated that he had discussed the matter with Nigel Davies, the solicitor who had drawn up the 2003 Lease between the Village Hall and Playing Field Committee and the Football Club, and who had agreed with the Clerk's interpretation of the provisions of the Lease. However, it was stated that Mr Davies had advised Mr Tomlins to request that, prior to the Club formally approaching the Committee on surrendering the Lease, that the Council be requested whether it would state at this juncture that it would agree in principle to take over the changing rooms.

(Councillor Tomlins then stopped taking part in the subsequent discussion on the matter.)

In response, the Clerk stated that he could only reiterate the advice he had given in the previous meeting, as recorded in Minute 441, which had been approved as a correct record at the commencement of this meeting, in that the Council should await the outcome of the Club's formal request to the Committee for surrendering the Lease and any subsequent request that could be made by the Committee to the Council to take over the changing rooms.

It was **RESOLVED** to accept the advice of the Clerk and to await any formal request that may be forthcoming from the Llanon Village Hall and Playing Fields Committee in future.

Council Gwenno Piette, the Council's representative on the Board of Governors explained that the play was aimed at the whole community and had an original English script.

- c) Councillor Lodwick Lloyd suggested that a guest speaker be invited in the Council's Christmas Dinner but it was agreed that it was late in the day to consider such a suggestion for this year.
