Councillor Dennis Morgan reported on the following matters:

- Playground – the grass needing cutting and the gate needed greasing.
- There were no problems with the tennis courts and Waun car park, but the 'Sutherlands corner' needed cutting and the seating area needed weeding.
- Morfa Beach – agreed to send a letter of thanks the developer of Stad Craig Ddu, Enzo Sauro.

679 The Chalet / Fishermen's Hut

Consideration was given to the up-to-date position – the Council had already decided to await lifting of Covid restrictions by the Welsh Government before holding an opening event during the school summer holidays.

It was also **RESOLVED** to place picnic benches for the Slang and to request Councillor Aled Roberts to obtain best prices.

680 Benches

It was reported that Dan Lewis had constructed the five bases at the Council's Slang and it was **RESOLVED** to proceed to purchase five 'Sandringham' benches made of recycled material and one multi-coloured seat for the playground.

681 Playground

It was **RESOLVED** to request the Secretary of the Llanon Village Hall and Playing Field Committee as to whether it had had an opportunity to consider the Council's request for additional land adjoining the playground.

Consideration was given to planning application A210559 - Land To The Rear of Cylch Peris, Llanon. Variation of condition 2 of planning permission A190018 - Approved plans.
DECISION: No objection but to request a condition requiring a 6ft fence to be erected in order to prevent overlooking of existing house at Cylch Peris.
- 684 Cynllun Grant Cymunedol Wales and West**
Cyfeiriodd y Cadeirydd ymweliad safle a gynhaliwyd yn ddiweddar gyda chynrychiolwyr Barcut a Morgan Construction pan y cytunwyd ganddynt i wneud y gwaith canlynol ar ran y Cyngor:

Codi stand ar gyfer beiciau ar y Waun
Trwsio'r pum mainc ac adleoli pyst rhwystro ar y Waun
Gosod sylfaen goncrid ar gyfer y fainc ger y man chwarae
Hysbysfwrdd ger Cylch Peris.

Dywedwyd hefyd y byddai Barcut yn dilyn i fyny cyllido darparu 'lle chwarae naturiol' ar gyfer y gymuned.

Prun bynnag, adroddodd y Clerc fod ebost pellach wedi'i dderbyn oddi wrth Barcut a oedd yn gofyn ai'r Cyngor oedd yn berchen y tir dan sylw ac a oedd modd iddo gyllido'r gwaith ei hun. Disgwylid cyngor pellach ac fe roddir copi o'r gohebiaeth diweddar hwn i'r Cyngorydd Sir Dafydd Edwards er mwyn ei ddilyn i fyny ar ran y Cyngor.
- 684 Wales and West Community Grant Scheme**
The Chairman referred to a site visit held recently with representatives of Barcut and Morgan Construction when they agreed to undertake the following work on behalf of the Council;

Erecting a bike stand at y Waun
Repairs to five benches and relocating of bollards at y Waun
A concrete base for the bench near the playground
A noticeboard at Cylch Peris.

It had also been indicated that Barcut would follow up financing the provision of a 'natural playground' for the community.

However, the Clerk reported receipt of a subsequent email from Barcut asking whether the Council owned the land in question and whether it could fund the work itself. Further advice was awaited and County Councillor Dafydd Edwards would be given a copy of this latest correspondence to follow up on behalf of the Council.

- b) Mewn ateb i gwestiwn gan y Cynghorydd Bryan Tomlins, dywedodd y Cynghorydd Sir Dafydd Edwards y byddai cyrbiau isel yn cael eu gosod yn Stad Graig Ddu ar yr amser priodol. Dywedodd y Cynghorydd Tomlins hefyd fod blodau gwyllt ganddo a allai gael eu plannu ar dir y Cyngor. Cytunwyd cysylltu gyda garddwr tirlunio a oedd wedi symud i'r ardal yn ddiweddar.
- c) Dywedodd y Clerc ei fod wedi cael gwybod gan y Cyngor Sir fod person lleol wedi gwrthwynebu gwaredu'r ffôn talu yn Llanon gan taw signal ffôn symudol anwadal sydd ganddi.
- d) Cyfeiriodd y Cynghorydd Phil Tomlins at y canlynol:
- damwain ar waelod Heol yr Eglwys y teimlwyd fod canghennau sy'n gorhangio yn ffactor a oedd wedi cyfrannu ato. Dywedodd y Clerc ei fod wedi cyfeirio hwn at y Cyngor Sir.
 - roedd mewn cysylltiad gyda Ray Ceredigion mewn perthynas â'r fenter Open Access Play yn yr ardal.
 - roedd Open Reach wedi cyhoeddi'n ddiweddar y byddai'n darparu gwell gwasanaeth ar gyfer yr ardal a fyddai wedyn yn rhwystro Wefibre rhag bwrw mlaen gyda'i cynllun nhw.
 - Cafwyd dau darparydd bagiau baw cwn gan GMGC ac y byddent yn cael eu gosod gyda'r ddau bin.

roof of the new chalet and Councillor Phil Tomlins stated that he had followed this up. Councillor Roberts stated that he had also been approached with concerns about the safety of residents of Hafan yr Efail crossing the road outside the property and an explanation was given as to previous discussions on this matter.

- b) In reply to a query by Councillor Bryan Tomlins, County Councillor Dafydd Edwards stated that dropped kerbs would be provided at the Stad Craig Ddu at the appropriate time. Councillor Tomlins stated that he also had wildflowers which could be planted on Council land. It was agreed to approach a landscape gardener who had recently moved into the area.
- c) The Clerk stated that he had received notification from the County Council that a local person had objected to the removal of the payphone at Llanon as she had an unstable mobile phone signal.
- d) Councillor Phil Tomlins referred to the following:
- an accident at the bottom end of Heol yr Eglwys which it thought that overhanging branches may have been a contributory factor. The Clerk stated that this had been referred to the County Council.
 - he was in contact with Ray Ceredigion in respect of the Open Access Play initiative for the area.
 - Open Reach had recently indicated that they would be providing an improved service for the area and that this therefore prevented Wefibre from proceeding with its scheme.
 - two dog poo bag dispensers had been acquired from CAVO and would be put in place together with the bins.
